Your letter dated April 4, 2024, submitting replacement Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. 612400934, in the amount of \$3,795,000, was received by our office on April 5, 2024. This bond, conditioned to cover Right-of-Way OCS-G 14264, was executed on February 16, 2024, with Poseidon Oil Pipeline Company, L.L.C. as principal and United States Fire Insurance Company as surety.

This bond replaces Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SUR0033503, in the amount of \$3,795,000. This bond, conditioned to cover Right-of-Way OCS-G 14264, was executed on February 9, 2016, with Poseidon Oil Pipeline Company, L.L.C. as principal, and Argonaut Insurance Company as surety.

- (b) to appoint, in writing, one or more persons for any or all of the purposes mentioned in the preceding paragraph (a), including affixing the seal of the Corporation.

Article III, Officers, Section 3.11, Facsimile Signatures. The signature of any officer authorized by the Corporation to sign any bonds, guarantees, undertakings, recognizances, stipulations, powers of attorney or revocations of any powers of attorney and policies of insurance issued by the Corporation may be printed, facsimile, lithographed or otherwise produced.
