Dear Ms. Koletar:

Your letter dated June 5, 2024, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. N-8100129, in the amount of \$281,113, was received by our office on that same date. This bond, conditioned to cover Right-of-Way OCS-G 28733, was executed on February 1, 2022, with Talos Energy Offshore LLC as principal and Indemnity National Insurance Company as surety.

Attached to and forming a part of Bond No. N-8100129 is Decrease Bond Rider, executed on December 22, 2023, which decreases the bond amount by \$47,381 for a total penal sum of \$233,732. The rider is effective December 22, 2023.

The Bureau of Ocean Energy Management has no objection to cancellation of Bond No. N-8100129, which is considered cancelled without residual liability effective June 18, 2024, the date of final concurrence with the cancellation.
