Dear Mr. McGregor:

Your letter dated February 27, 2025, requesting termination of the period of liability and cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. 612403086, in the amount of \$500,000, was received by our office on February 28, 2025. This bond, conditioned to cover Lease OCS-G 21807, all of Block 606, Green Canyon, was executed on September 30, 2021, with OGOG (GOM 1) Inc. as principal and United States Fire Insurance Company as surety.

Attached to and forming a part of Bond No. 612403086, is Bond Rider No. 1, executed on July 26, 2022, which changes the name of the principal from OGOG (GOM 1) Inc. to OGOG (K2) Inc. The rider is effective July 14, 2022.

The Bureau of Ocean Energy Management has no objection to termination of Bond No. 612403086. The period of liability is considered to have terminated effective February 28, 2025, the date of final concurrence with the termination, except as to any liability which may have accrued prior to that date.

Notwithstanding the fact that the period of liability under the above-described bond has terminated, the bond cannot be cancelled until seven years after the termination of the lease, six years after completion of all bonded obligations, or at the conclusion of any appeals or litigation related to your bonded obligations, whichever is the latest. When these requirements have been met you may submit a written cancellation request.

Please note that during the aforementioned period, to cover actual or potential outstanding obligations associated with the herein identified lease, you may provide acceptable security, pledged collateral or another corporate surety bond to the Bureau of Ocean Energy Management in lieu of the above-described surety.

Please let this letter serve as OGOG (K2) Inc.'s (formerly OGOG (GOM 1) Inc.) (GOM No. 03614) request for cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. 612403086 covering Lease No. OCS-G 21807, All of Block 606, Green Canyon (the "Lease"), which was issued by United States Fire Insurance Company as Surety, dated September 30, 2021 and in the amount of \$500,000.00 (the "Bond"). A copy of the Bond is enclosed for your reference.

As reflected in BOEM/BSEE's records, there are several area-wide bonds currently supporting the Lease and the obligations associated therewith, namely the following:

- Outer Continental Shelf (OCS) Mineral Lessee's or Operators Bond No. **22015867**, in the amount of \$3,000,000.00, effective as of July 11, 2005, with **Anadarko Petroleum Corporation** as principal and Liberty Mutual Insurance Company as surety, conditioned to cover principal's leasehold interests held now or hereafter in the Gulf of Mexico.<sup>1</sup>
- Outer Continental Shelf (OCS) Mineral Lessee's or Operators Bond No. **2971100-2657**, in the amount of \$3,000,000.00, effective as of September 15, 1997, with **Anadarko US Offshore LLC** as principal and Safeco Insurance Company of America as surety, conditioned to cover principal's leasehold interests held now or hereafter in the Gulf of Mexico.<sup>2</sup>

<sup>2</sup> Bond Rider No. 6, effective as of December 26, 2015, changed the name of the principal from Anadarko US Offshore Corporation to Anadarko US Offshore LLC. Anadarko US Offshore LLC is a record title holder in the Lease. There is no severance of operating rights from record title associated with the Lease.



- Outer Continental Shelf (OCS) Mineral Lessee's or Operators Bond No. **RLB0015613**, in the amount of \$3,000,000.00, effective as of May 16, 2014, with **JX Nippon Oil Exploration (U.S.A.) Limited** as principal and RLI Insurance Company of America as surety, conditioned to cover principal's leasehold interest held now or hereafter in the Gulf of Mexico.<sup>3</sup>

Pursuant to applicable regulations, OGOG (K2) Inc.'s bonding obligation was previously satisfied by issuance of the area-wide bonds identified above, such that issuance of the Bond was not required. See 30 C.F.R. § 556.900(c).

Accordingly, OGOG (K2) Inc. requests written cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. 612403086 terminating the period of liability of the Bond and cancelling the Bond without residual liability.

3. If the Regional Director terminates the period of liability of this bond, the Surety will remain responsible for Obligations that accrued during the period of liability until the Regional Director issues a written cancellation of the bond in favor of the Surety.
4. If this bond is cancelled, the Regional Director may reinstate this bond as if no cancellation had occurred if any payment of any obligations of the Principal(s) is rescinded or must be restored pursuant to any insolvency, bankruptcy, reorganization, or receivership, or should the representation of the Principal that it has paid its financial Obligations or performed the other



Obligations of the lease in accordance with BOEM specifications be materially false and BOEM relied upon such representation in canceling the instrument.

5. The Surety waives any right of notice of this bond taking effect and agrees that this bond will take effect upon delivery to BOEM.
6. The Surety's Obligations will remain in full force and effect, even if:
  - (a) Any person assigns all or part of any interest in an Instrument covered by this document.
  - (b) Any person modifies an Instrument or Obligation under an Instrument in any manner including modifications that result from a commitment to a unit, cooperative, communitization, or storage agreement; suspension of operations or production; suspension or changes in rental, minimum royalty, or royalties; modification of regulations or interpretations of regulations; creation or modification of compensatory royalty agreements or payments; or creation of any mortgage, pledge, or other grant of security interest in the Instruments.
  - (c) Any person, event, or condition terminates any Instrument covered by this bond, whether the termination is by operation of law or otherwise.
  - (d) BOEM takes or fails to take any action in enforcing, as against any party to the Instrument, the payment of rentals or royalties or the performance of any other covenant, condition or agreement of the lease, or giving notice of or making demand with respect to such nonperformance.
  - (e) The Surety suffers any loss by reason of any law limiting, qualifying, or discharging the Principal's Obligation.
7. The Surety agrees to be bound under this bond as to the interests in any Instrument retained by the Principal when BOEM approves the transfer of any or all of the Instruments or interests in the Instruments.
8. In the event of any default under a lease, the Surety must provide payment of all of the cost of the Obligations of the Principal upon demand by BOEM.
9. If BOEM decides to commence suit to enforce its rights, it may commence and prosecute any claim, suit, action, or other proceeding against the Principal and Surety, or either of them, whether or not BOEM joins the lessees or any other party.
10. In the event there is more than one Surety for the Principal's performance of the Obligations, as to any Instrument, the Surety's Obligation and liability under this bond is on a "solidary" or "joint and several" basis along with other guarantors or sureties.
11. The Surety agrees to give prompt notice to BOEM and the Principal of any action filed alleging the insolvency or bankruptcy of the Surety or the Principal, or alleging any violation that would result in suspension or revocation of the Surety's charter or license to do business.

- (a) to execute, affix the corporate seal manually or by facsimile to, acknowledge, verify and deliver any contracts, obligations, instruments and documents whatsoever in connection with its business including, without limiting the foregoing, any bonds, guarantees, undertakings, recognizances, powers of attorney or revocations of any powers of attorney, stipulations, policies of insurance, deeds, leases, mortgages, releases, satisfactions and agency agreements;
- (b) to appoint, in writing, one or more persons for any or all of the purposes mentioned in the preceding paragraph (a), including affixing the seal of the Corporation.

Article III, Officers, Section 3.11, Facsimile Signatures. The signature of any officer authorized by the Corporation to sign any bonds, guarantees, undertakings, recognizances, stipulations, powers of attorney or revocations of any powers of attorney and policies of insurance issued by the Corporation may be printed, facsimile, lithographed or otherwise produced. 
